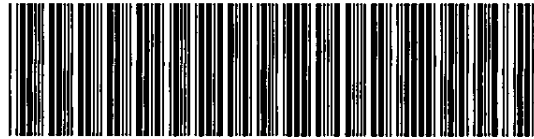

LIGHT of Southwest Florida, Inc.

Article I
Name

Section 1.1

The name of this corporation shall be LIGHT of Southwest Florida, Inc.,

Article II

Article III
Purpose

Section 3.1 Purpose

The purpose of LIGHT of Southwest Florida, Inc. shall be to provide individuals diagnosed with cancer financial help in meeting the costs of therapies to treat their cancer by assisting these individuals with financial assistance to meet copays and coinsurance they are unable to pay for the treatment of their disease.

LIGHT of Southwest Florida, Inc. shall receive and maintain a fund or funds of real or personal property, or both, and subject to the restriction and limitations hereinafter set forth, to use and apply the whole or any part of the income thereof and the principal therefore exclusive for charitable purposes.

No part of the net earnings of the corporation shall inure to the benefit of any trustee, officer, employee, or private individual (except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes), and no trustee, officer, employee, or private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation. No part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal

income tax under the section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IV Manner of Election

Section 4.1 Directors

The Board of Directors shall constitute the governing body of LIGHT of Southwest Florida, Inc. and shall consist of not less than five (5) nor more than (20) Directors. The Directors shall be elected annually.

Section 4.2 Officers

The Board of Directors officers shall consist of the President, Vice-President, Secretary and Treasurer. The officers shall be elected annually. The four officers and the Executive Director shall comprise the Executive Committee.

Section 8.1 Dissolution

Upon the dissolution of the corporation, assets shall be distributed exclusively to charitable organizations which qualify under the provisions of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article IX
Membership

Section 9.1 Membership

Membership in LIGHT of Southwest Florida, Inc. shall not discriminate on the basis of race, color, national or ethnic origin, age, sex, sexual orientation, disability or any other unlawful factor.
