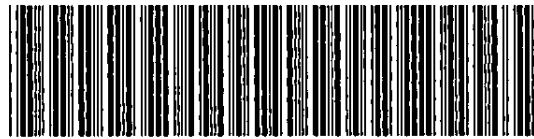

ARTICLE II

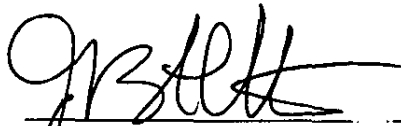
The document number of the Corporation is N07000003662.
