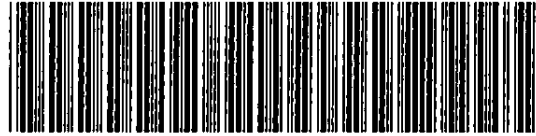

# ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

## ARTICLE I      NAME

The name of the corporation shall be:

New Life Christian Center, Inc.

## ARTICLE II      PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

14351 N.E. 4<sup>TH</sup> Avenue, Miami, Florida, 33161

## ARTICLE III      PURPOSE

The purpose of the corporation is:

*organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code;*

*to sustain the worship and ordinances of Christian religion in accordance with the laws of the Old and New Testament and the policy of the Christian church;*

*to support and conduct non-partisan research, education and informational activities to increase public awareness of juvenile delinquency;*

*to combat crime within neighborhoods; and*

*to prevent community deterioration.*

#### **ARTICLE IV**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not, except to an unsubstantial degree, engage in any activities or exercise any powers that are not in the furtherance of the purposes of this corporation.

#### **ARTICLE V**

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal code, or shall be distributed to the federal government, or to a state or local government, for a purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such operated exclusively for such purposes.

#### **ARTICLE VI      MANNER OF ELECTION**

The manner in which the directors are elected or appointed:

The Board of Trustees shall elect from among its members a Chairman, Vice Chairman, Executive Secretary and Treasurer. These officers and/or directors shall be elected by a majority vote. Any officer and/or director may be removed at any time by an affirmative vote of a majority of the whole Board of Trustees. Officers and/or directors shall perform such duties as prescribed in the bylaws.




