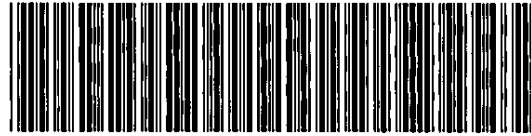

SECOND: Article I is hereby deleted in its entirety and is hereby replaced and superseded by the following new Article I.


ARTICLE I

There are no members entitled to vote on the Amendment. The Amendment was adopted by the Board of Directors on June 7, 2007.


