#### **ARTICLES OF INCORPORATION**

OF

#### FLORIDA DAYS HOMEOWNERS ASSOCIATION, INC.

The undersigned hereby files these Articles for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liability, privileges and immunities of a corporation for not for profit.

#### ARTICLE I NAME

The name of this corporation shall be **FLORIDA DAYS HOMEOWNERS ASSOCIATION, INC.** 

## ARTICLE II DURATION

Existence of this corporation shall commence with the filing of these Articles with the Secretary of State and shall exist perpetually unless sooner terminated in accordance with law.

# ARTICLE III PURPOSE, AND DUTIES

This corporation is organized for the purpose of providing an entity for the maintenance and operation of a homeowners association located in New Smyrna Beach, Volusia County, Florida, and known or to be known as FLORIDA DAYS HOMEOWNERS ASSOCIATION, INC. The Corporation shall operate, maintain and manage the common property and shall assist in the enforcement of the restrictions and covenants contained in the DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS FOR FLORIDA DAYS SUBDIVISION.

The Association shall operate, maintain and manage the surface water or stormwater management system(s) in a manner consistent with the St. Johns River Water Management District permit no. 42-127-103546-1 requirements and applicable District rules, and shall assist in the enforcement of the Declaration of Covenants and Restrictions which relate to the surface water or stormwater management system.

ARTICLES OF INCORPORATION FLORIDA DAYS HOMEOWNERS ASSOCIATION, INC.

The Association shall levy and collect adequate assessments against members of the Association for the costs of maintenance and operation of the surface water or stormwater management system.

#### ARTICLE IV MEMBERS

The qualification of members and the manner of their admission shall be as regulated by the Bylaws and Declaration of Restrictions for FLORIDA DAYS.

# ARTICLE V PRINCIPAL PLACE OF BUSINESS INITIAL REGISTERED OFFICE AND AGENT

The principal place of business and general office of this corporation will be 1785 Victory's Path Trail, New Smyrna Beach, Volusia County, Florida 32168, but it may maintain offices and transact business at such other places, either within or outside the State of Florida, as the Board of Directors may from time to time provide by resolution.
