2- Upon dissolution of the Organization or the winding up of its affairs, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the internal Revenue code, or corresponding federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the court of common pleas of the county in which the principal office of the organization is then located, exclusively for such purposes, or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

3- Additional purpose of the Organisation du Collège Immaculée Conception is:

- a) To provide financial and material support to the operations of the secondary school known as Collège Immaculée Conception and located in the city of Gonaives in Haiti.
- b) To create better educational opportunities for the youths of Gonaives, Haiti, through Collège Immaculée Conception.
- c) To enhance Collège Immaculée Conception's students' academic progress through cultural, athletic, recreational, intellectual, and social activities.
- d) To reconnect and reunite the alumni of Collège Immaculée Conception of Gonaives, Haiti, living in the USA for continuous social and cultural interaction
- e) To provide direction to former students of Collège Immaculée Conception immigrating to the USA, especially in the state of Florida, and in need of guidance on how to get involved in the community, where to find services and ressources, how to register for school, how to choose a career path, what types of documents they will need, etc...

Article III PURPOSE

1- L'Organisation des Anciens du Collège Immaculée Conception, Inc (also known as OACIC, Inc) is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue code or corresponding section of any future federal tax code. The Organization may receive and administer such purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 and to that end, the Corporation is empowered to conduct fundraising activities, request mail and online donations, hold any property, or any undivided interest therein, without limitation as to amount or value; to dispose of any such property and to invest, reinvest, or deal with the principal or the income in such manner as, in the judgment of the directors, will best promote the purposes of the Corporation, without limitation, except such limitations, if any, as may be contained in the instrument under which such property is received, these Articles of Incorporation or any applicable laws, to do any other act or thing connected with the foregoing purposes or in advancement thereof, but not for the pecuniary profit or financial gain of its directors (Continued on additional attached sheet)
