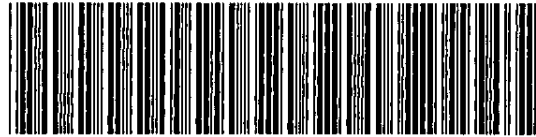

ARTICLES OF INCORPORATION OF SURELY WE'LL WIN GLORY MINISTRIES SELAH INC.

ARTICLE I

The name of the incorporation is "Surely We'll Win Glory Ministries Selah Inc."

ARTICLE II

The corporation is organized pursuant to the Florida Nonprofit Corporation Code Statute 617.

ARTICLE III

The street of the initial registered office is: 5008 Central Ave. South. St. Petersburg, FL 33707. The CEO is Evangelist Linda D. Leavell

ARTICLE IV

The Corporation is a Non-profit Corporation and is organized for the following purpose: To feed and clothe the hungry. We mainly want to get people in to the Church (Surely We'll Win Glory Ministries Selah Inc.), this will stop a lot of crime. We just believe and know God is well able to direct people in the right direction.

ARTICLE V

All of the affairs of the Corporation will be managed by a board of directors.

ARTICLE VI

The principal mailing address of the Corporation is 5008 Central Ave. South. St. Petersburg, FL 33707.

ARTICLE VII

The Corporation is not organized and shall not be operated for pecuniary gain or profit. No part of the property of the Corporation and no part of its earning shall inure to the benefit of any director or other private individual (except that reasonable compensation may be paid for services rendered to or for the Corporation in furtherance of one or more of its purposes). The Corporation shall never be authorized to engage in a regular business of a kind ordinarily carried on for profit or in any other activity except in furtherance of the purposes stated above for which the Corporation is organized. The Corporation shall never engage in propaganda, attempt to influence legislation, or participate in any political campaign on behalf of any candidate for public office, nor shall any part of its property or any part of the income therefrom be devoted to such purposes.

ARTICLES OF INCORPORATION OF SURELY WE'LL WIN GLORY MINISTRIES SELAH INC.

Article VIII

The members of Surely We'll Win Glory Ministries Selah Inc votes for the Board of Directors of this organization by the majority vote. Board members will stay in office for(4) four years then vote again in two years for re-election.

ArticleVIII

The C.E.O. of Surely We'll Win Glory Ministries Selah Inc will be voted for re-election only if C.E.O. Evangelist Linda D. Leavell resigns. Then the members of Surely We'll Win Glory Ministries Selah Inc. will vote by the majority for a new C.E.O. every (4) four years.
