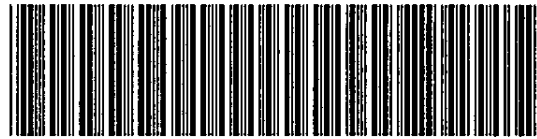

ARTICLES OF INCORPORATION

ARTICLE I NAME

The name of the corporation shall be: Florida Keys Wastewater Assistance Foundation, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 91645 Overseas Highway, Tavernier, FL 33070.

ARTICLE III PURPOSES

The purposes for which the corporation is organized are: exclusively charitable, educational, and scientific purpose, including, for such purposes, the making of distributions to organization that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV NUMBER AND MANNER OF ELECTION OF DIRECTORS

The number and manner in which the directors are elected shall be stated in the bylaws.

ARTICLE V INITIAL REGISTERED AGENT AND STREET ADDRESS

The name and Florida Street address of the registered agent is: Nicholas W. Mulick, 91645 Overseas Highway, Tavernier, FL 33070.

ARTICLE VI INCORPORATOR

ARTICLE VII NO DISTRIBUTION OF EARNINGS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of the articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt for federal income tax under section (501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code.

ARTICLE VIII DISTRIBUTION OF ASSETS UPON DISSOLUTION


Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purpose within the meaning of section (501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such

organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE IX NO MEMBERS


The corporation shall have no members.
