The undersigned incorporator of a corporation not for profit under Chapter 617 of the Florida Statutes, hereby adopts the following articles of incorporation.

Article I Name:

The name of this corporation is FSU COM/TREASURE COAST, INC.

Article II Purposes:

The purposes of the corporation are to seek affiliation with various healthcare providers and facilities in the Treasure Coast area of Florida including, but not limited to, the city of Ft. Pierce, as authorized by Section 1004.42 of the Florida Statutes, in order to provide clinical instruction for students enrolled in community-based medical education programs at The Florida State University College of Medicine.

The corporation is organized and shall be operated to advocate for and provide support to The Florida State University College of Medicine's educational programs and to enhance existing health-related educational programs in the Treasure Coast communities of Florida including, but not limited to, the city of Ft. Pierce.

Article III Member:

Membership in this corporation shall be limited to The Florida State University, a state university existing pursuant to the laws of the State of Florida.

Article IV Initial Registered Office and Agent: Priverpal

The street address of the initial registered office of the corporation is The Florida State University, 211 Westcott Building, Tallahassee, Florida 32306-1470. The name of the initial registered agent at such office is Betty Steffens.

Article V Incorporator:

The name and residence of the incorporator of this corporation is The Florida State University, 211 Westcott Building, Tallahassee, Florida 32306-1470.

Article VI Directors:

The directors of this corporation shall consist of no less than three (3), and no more than fifteen (15), individuals to be appointed by, and serve at the pleasure of, the President of The Florida State University, in accordance with the terms and provisions of the bylaws. The initial board of directors shall consist of those individuals who are duly serving in the following capacities within the College of Medicine: Assistant Dean, Ft. Pierce campus; Senior Associate Dean for Academic Affairs; and the Director of Community Clinical Relations.

Article VII Bylaws:

The Member may, from time to time, alter, amend, or repeal the bylaws of the corporation, or may adopt new bylaws regulating the operation of the corporation.

Article VIII Amendments:

These articles of incorporation may be amended from time to time by the Member.

Article IX Dissolution:

This corporation may be dissolved at any time with the written consent of the Member. Upon dissolution, the assets of the corporation shall be conveyed or assigned to any nonprofit corporation, association, or other organization devoted to purposes similar to those for which this corporation has been organized.
