**ARTICLE 1: NAME** 

The name of the corporation shall be: RESTORATION OF FAITH OUTREACH MINISTRIES, INC.

### **ARTICLE 2: PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be: 7831 NE 185th Avenue, Williston, Florida 32696.

#### **ARTICLE 3: PURPOSE**

A not for profit corporation, organized and existing under the laws of the State of Florida.

- A.
