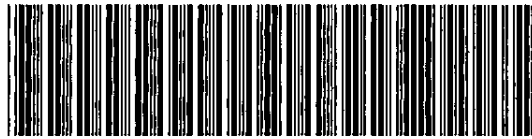

**ARTICLE ONE
NAME**

The name of this corporation is The Florida Association of Independent Special Education Facilities, Inc.

**ARTICLE TWO
NAME AND ADDRESS OF INITIAL REGISTERED AGENT**

The name and address of the initial registered agent is Jacqueline Egli, 894 Gary Hillery Drive, Winter Springs, Florida 32708.

**ARTICLE THREE
STATEMENT OF CORPORATE NATURE AND PURPOSES**

This is a nonprofit corporation organized solely for general charitable purposes pursuant to the Florida Not For Profit Corporation Act set forth in Part I of Chapter 617 of the Florida Statutes.

The Florida Association of Independent Special Education Facilities, Inc. will exist for the express purpose of providing a support organization for facilities serving exceptional children, making services known to parents of such children, providing an effective voice for such facilities and serving as a representative association to improve communication between public and private institutions.

**ARTICLE FOUR
DEDICATION OF ASSETS**

The property of this corporation is irrevocably dedicated to promoting the above-stated corporate purposes.

No part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof.

**ARTICLE FIVE

**ARTICLE SIX
MANAGEMENT OF CORPORATE AFFAIRS**

The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a board of directors. The number of directors of the corporation shall be three; provided, however, that such number may be changed by an amendment to the bylaws and election by the members. Membership eligibility will be defined in the bylaws.


**ARTICLE SEVEN

Acceptance of Registered Agent**

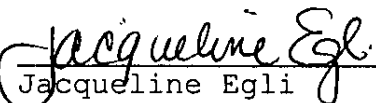
Pursuant to the provisions of the Florida Statutes the non-profit corporation identified below submits the following statement in designating its registered office and registered agent in the state of Florida:
