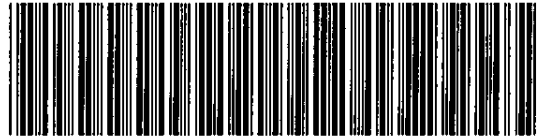

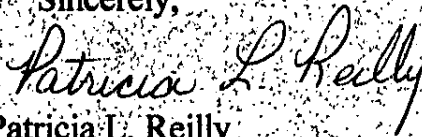

**Articles of Incorporation  
For  
The Barbara M. Stone Justice and Peace Center, Incorporated**

The following Florida non-profit Corporation is being organized by the following Florida resident pursuant to Chapter 617.0202, F.S. of the Florida Statutes.

**ARTICLE I  
Name of Corporation**

The name of the Florida non-profit Corporation shall be The Barbara M. Stone Justice and Peace Center, Incorporated.

**ARTICLE II  
Place of Business and Mailing Address**

The Corporations principal place of business and mailing address shall be at 1410 La Casita Street, Deltona, Florida 32725.

**ARTICLE III  
Purpose of Corporation**

The purpose of the Corporation shall be to conduct business as a non-profit Community Economic Corporation in the State of Florida in order to meet the socioeconomic needs of those individuals who are underprivileged and underserved in their communities. This will be facilitated with various programs, training opportunities and services as needed in the communities that the Corporation serves.

**ARTICLE IV  
Appointment / Election of Directors**

The Board of Directors shall be appointed initially by the founder of the Corporation, Mrs. Patricia Reilly, and will serve in their capacity for a period not to exceed twelve months. The existing Board of Directors will appoint, on an annual basis, a Nominating Committee from the community served, who will be responsible to recommend to the Board of Directors a slate of qualified individuals to be considered to hold the positions, offices and function in the

various capacities as is deemed necessary to conducted the business of the Corporation. The existing Board of Directors shall consider and vote upon the candidates presented to them by the Nominating Committee and shall be able to elect and install such candidates to their elected office by a simple majority vote. There shall be no prohibition of an existing officer and/or board member exceeding him or herself and shall serve the Corporation at the pleasure of the corporation.

## **ARTICLE V**

**Dissolution of Corporation**

At such time as the Board of Directors elect to dissolve the Corporation, as is in compliance with the Bylaws of the Corporation, all outstanding debts and financial obligations of the Corporation shall be paid in full from the proceeds of the Corporation and any assets remaining of the Corporation shall be given, transferred, deeded to and/or conveyed in full to another non-profit Corporation in good standing, and/or to a government agency as in compliance with current standing Internal Revenue Service statues and/or regulations governing non-profit corporations.

**ARTICLE IX**  
**Non Discrimination Policy**

The Corporation shall not in any manner discriminate against any individual(s), person(s) or groups of people(s) for any reason as stated in current Federal Statues, State of Florida Statues, or because of a persons race, creed, sex, national origin, or sexual orientation. Therefore, all individual(s), person(s) or groups of people(s) shall have full and complete access to all the programs and benefits of the Corporation and shall be, with appropriate qualification(s), credential(s) and/or certification(s) to perform such job vacancy and considered for full employment in the Corporation.
