

Florida Statute Chapter 617

- Article 1. Name. The name of the Corporation is: Hernando Youth Ministers Association, Inc.
- Article 2. Members. The Corporation will have members as outlined in the Bylaws.
- Article 3. Registered Agent and Principal Office. The Registered Agent of the Corporation shall be Timothy Richter, resident of the State of Florida, whose address is 475 North Avenue West, Brooksville, Fl 34601 The principal office of the Corporation is 475 North Avenue West, Brooksville, Florida 34601.
