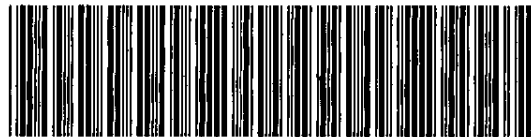

### **ARTICLE I      NAME**

The name of the corporation shall be: Faith to Faith Ministries INC.

### **ARTICLE II      PRINCIPAL OFFICE**

### **ARTICLE III      PURPOSE**

The purposes for which the corporation is organized exclusively religious within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Revenue law. Notwithstanding and other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
