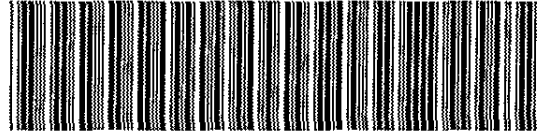

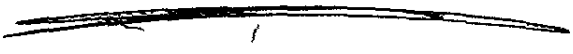

# ARTICLES OF INCORPORATION OF “DOGS INN”, INC.

The undersigned, for the purpose of forming a Non-Profit corporation, under the Non-Profit Law of the United States, hereby adopt the following Articles of Incorporation.

## ARTICLE I (Name)

The name of the corporation:

“DOGS INN”, INC.

## ARTICLE II (Duration)

The duration of this corporation is perpetual.

## ARTICLE III (Purpose)

The general purpose for which this corporation is organized is to engage in the operation of EXCLUSIVE FOR CHARITABLE, EDUCATIONAL AND A NON-PROFIT MEANS OF RESCUING ANIMALS, SAVING ANIMALS LIVES, ADOPTING OUT, FOSTERING ANIMALS THIS BEING NOT LIMITED TO MEDICAL FOSTERING, BRINGING ANY AND ALL FORMS, UNLIMITED FORMS OF, ANIMAL BENEFITS OR PROMOTIONS (FOR ALL ANIMALS, PRIMARILY DOGS AND CATS), EXISTING OR YET TO EXIST, OF ANIMAL PRODUCTS, AND OR DISTRIBUTION, SALES, PROMOTIONS, GROOMING, BOARDING, DAY CARE, THE MAKING OF DISTRIBUTIONS TO ORGANIZATIONS THAT QUALIFY AS EXEMPT ORGANIZATIONS UNDER SECTION 501 ( C ) ( 3 ) OF THE INTERNAL REVENUE CODE, OR THE CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE.

#### ARTICLE IV

(Initial Registered Office, Registered Agent, Principal Office, and Mailing Address).

#### ARTICLE V

(Initial Board of Directors And Or Officers)

This corporation shall have one director initially. The number of directors may be either increased or diminished from time to time by a majority of the shareholders present in person or by proxy at any annual or special meeting of the shareholders but shall never be more than 3 directors or less than one. ## ARTICLE VII (Amendment)

This corporation reserves the right, subject to the approval of persons voting not less than two-thirds majority of the outstanding fully paid and non-assessable shares of the capital stock of the corporation, to amend or repeal any provision contained in these Articles of Incorporation, or any amendment to them, and any right conferred upon the shareholders, is subject to this reservation. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

## ARTICLE VIII (Amendment)

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IX  
(Amendment)

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 ( c ) ( 3 ) of the Internal Revenue Code, or the corresponding section or any future federal tax code, or shall be distributed to the federal government, or to a state local government, for public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

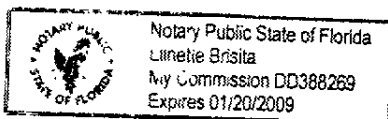
