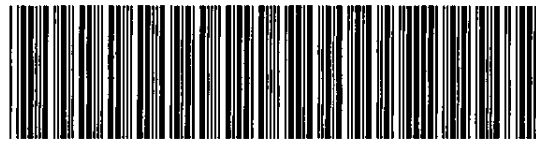

**Articles of Incorporation of
TRUST GOD MINISTRIES, INC.**

The undersigned incorporator(s), in order to form a non-profit corporation under the laws of the state of Florida, adopt the following Articles of Incorporation:

ARTICLE I

The name of this corporation shall be: Trust God Ministries, Incorporated.

ARTICLE II

The principal place of business and mailing address of this corporation shall be:

ARTICLE III

The specific purposes for which this corporation is organized are:

- (1) To gain more insight of the mind of Christ and spread the Gospel in the communities and find out the needs of people in the communities.
- (2) To identify and train ministry outreach leaders and establish a bible study for discipleship training in order to support the primary mission of the ministry.
- (3) To establish "support group" fellowships to address such issues as youth crime, teenage pregnancy, health issues, financial planning, and marital issues as the primary means of ministering to those that are evangelized.
- (4) To facilitate unity among other churches, and partnership with other organizations to host community events to put people face to face with resources and opportunities to bring about restoration in the communities.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE IV

The Incorporator shall appoint the initial Directors. Future Director vacancies on the Board of Directors shall be filled accordingly: (a) The President/Pastor shall nominate director candidates and (b) a quorum of the Board of Directors shall grant final approval. If the number of Directors then in office is less than a quorum, a vacancy on the board may be filled by approval of a majority of the directors then in office or by a sole remaining director. A person elected to fill a vacancy on the board shall hold office until the next election of the Board of Directors or until his or her death, resignation or removal from office.
