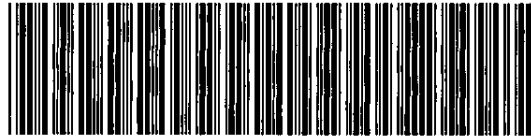

ARTICLES OF INCORPORATION
In Compliance with Chapter 617, (Not for Profit)

ARTICLE I
NAME

The name of this corporation shall be: **LADIES of GRACE OUTREACH MINISTRIES, Inc.**

ARTICLE II
PRINCIPAL OFFICE

The corporation's registered office is located at: 5598 Fischer Dr, Lakeland, FL 33812

ARTICLE III
PURPOSE

This corporation is organized exclusively for **RELIGIOUS** purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that also qualify as Section 501(c)(3) exempt organizations. To this end, the corporation shall hold quarterly meeting to plan, strategize the overall operations concerning the fellowship meetings along with an annual Conference, where we provide strength spiritual development of women. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
