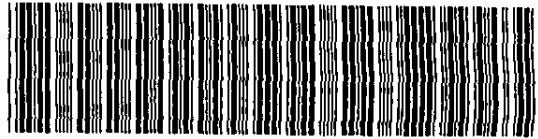

Article of Incorporation

Of

Blanche Ely High Class of 1965, Inc.

(A Corporation Not-For-Profit)

WE, the undersigned, desiring to form a corporation not-for-profit, pursuant to the provisions of Chapter 617 of the Florida Statutes, hereby certify as follows:

Article I Name

The name of this corporation will be: Blanche Ely High Class of 1965, Inc.

The principal place of business and mailing address of this corporation shall be:

*217 Northwest 15th Street
Pompano Beach, FL 33060-5436*

Article II Purpose

The purpose of this corporation shall be establish an organization for the purpose of promoting a desire for higher education among the students of Broward County Schools, specifically ELY HIGH, as long as it is operated as a public high school, or any other Broward County School, selected by the membership, to have one of its deserving students receive financial assistance for the advancement of higher education from the said corporation.

In furtherance of the foregoing purpose, the corporation shall have the power to solicit bequest, donations, gifts, and grants, both monetary and real property. The corporation shall manage such property, and to do any and all other things necessary or convenient for the fullment of the purpose of this corporation.

Article II Purpose
(Continued)

To borrow or raise monies for any of the purposes of the corporation and, from time to time, without limit as to amounts, to draw, make, accept, endorse, execute and issue promissory notes, bills of exchange, warrants, bonds, debentures and other negotiable or non-negotiable instruments and evidences of indebtedness and to secure the payment of any thereof and of the interest thereon by mortgage upon or pledge, conveyance or assignment in trust of the whole or any part of the property of the corporation, whether at the time owned or thereafter acquired, and to sell, pledge or otherwise dispose of such bonds or other obligations of the corporation for its corporation purposes.

The foregoing objects and purposes shall, except when otherwise expressed, be in no way limited to or restricted by reference to, or inference from, the terms of any other clause of this or any other Article of these Articles of Incorporation or of any amendment thereto, and shall each be regarded as independent and constructed as powers as well as objects and purposes.

The corporation shall be authorized to exercise and enjoy all the powers, rights and privileges granted to, or conferred upon, any corporation of a similar character by the laws of the State of Florida now or hereafter in force, and to do any and all the things heretofore set forth to the same extent as natural persons might or could do.

Article III Qualification of Members

The membership of this corporation shall constitute all persons who are named herein as Subscribers and such other persons as from time to time hereafter may become members in the manner provided in the BY-LAWS.

Article IV Manner of Election

The manner in which the directors are elected or appointed shall be by majority vote of the membership. All board of directors and officers will be elected every three years at a follow-up meeting after each three year reunion.

Article V Dues

Annual dues may be assessed in such amount as may be provided in the By-Laws.

Article VI Term of Existence

This corporation is to have perpetual existence.

Article VIII Officers

Section I. The officers of this corporation shall be the President, Vice President, Secretary, Treasurer and such additional officers as shall, from time to time, be authorized by the By-Laws or determined by the membership. Any person may hold two or more offices and no person holding two or more offices, shall sign any instrument in the capacity of more than one office. All such officers shall be elected by the membership and shall serve at the discretion thereof, except where the By-Laws make exceptions.

Section II. The Corporation may provide in its By-Laws for the holding of additional regular meetings and any special meetings and shall provide notice of all such meetings.

Section III. A quorum for the holding of any meeting shall consist of five members, one of whom shall be an officer of the corporation.

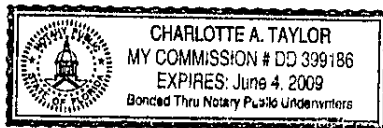
