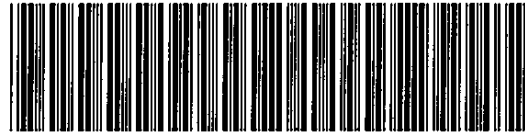

ARTICLE I.

The name of this corporation is 6942 ROSEMONT DRIVE CONDOMINIUM ASSOCIATION, INC. The initial principal office of the corporation is 6942 Rosemont Drive, Englewood, FL 34224, and the mailing address of the corporation is 6942 Rosemont Drive, Englewood, FL 34224.

ARTICLE II.

The purpose for which this corporation is organized is to act as the governing association of the proposed 6942 ROSEMONT DRIVE CONDOMINIUM ASSOCIATION, INC., a Condominium, located in Charlotte County, Florida, and to operate property owned by the Association.

ARTICLE III.

The terms used in these Articles of Incorporation shall have the same definitions and meanings as those set forth in the Declaration of Condominium of 6942 ROSEMONT DRIVE CONDOMINIUM ASSOCIATION, INC., a Condominium.

ARTICLE IV.

The qualification of members and the manner of their admission shall be as follows: Any person or persons who hold title in fee simple to a condominium unit in 6942 ROSEMONT DRIVE CONDOMINIUM ASSOCIATION, INC., a Condominium, shall by virtue of such ownership be a member of this corporation.

ARTICLE V.

This corporation shall exist perpetually.

ARTICLE XIII.


This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation.

ARTICLE XIV.






