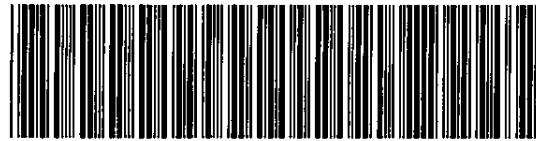

Articles of Incorporation

of

Krishna Cooperative, Inc.

The undersigned, acting as the incorporator of a corporation pursuant to chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

Article I

Name

The name of the corporation shall be Krishna Cooperative, Inc.

Article III

Purposes

The specific purposes for which the corporation is organized are:

1. To propagate, among the members and society at large, the beliefs and practices of the Krishna Consciousness religion according to the teachings of Sri Chaitanya Mahaprabhu as presented in disciplic succession in the writings of A.C. Bhaktivedanta Swami, Srila Prabhupada;
2. To bring the members of the Society, together with each other and nearer to Krishna, the prime entity, Vedic knowledge and self-realization, the prime goal of life, and thus to develop the idea, within the members, and humanity at large, that each soul is part and parcel of the quality of Godhead (Krishna);
3. To bring the members closer together for the purpose of teaching a simpler, more natural way of life;
4. To revitalizing Vaisnava culture and tradition through educational programs to preserve and promote the spiritually based duties of the different sections of varnashram-dharma society, i.e. the intellectual/religious, leadership, mercantile, and artisan.

5. With a view towards achieving the aforementioned purposes, to provide various spiritually based social services, and to publish and distribute periodicals, magazines, books, religious artifacts, and other writings;
6. To engage in any activity and exercise any power or authority that may be engaged in by a non-profit corporation organized under Chapter 617, Florida Statutes, as amended.

Article VI Limitation of Corporate Powers

The corporate powers of this corporation are as provided in Section 617.0302, Florida Statutes, unless limited as follows:

(a) This corporation is organized and operated exclusively for religious, educational and charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

(b) The corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible Section 170(c)(2) of the Internal Revenue Code.

(c) No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of

statements) on behalf of, or in opposition to, any candidate for public office.
