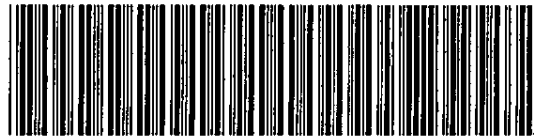

**ARTICLES OF INCORPORATION
OF

(A Not-for-Profit Corporation)**

ARTICLE I: CORPORATE NAME

The name of the Corporation shall be **LIFE CHANGING ANOINTING, INC.**

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address is:

ARTICLE III: PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business in the State of Florida. This Corporation shall be a non-profit corporation and is organized exclusively for charitable, religious and educational purposes under section 501(c)(3) of the Internal Revenue Code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any further federal tax code, or (b) by an organization, contributions to which are deductible under section 17(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code, or shall be distributed to the federal government, or a state or local government, for a public purpose.

ARTICLE IV: APPOINTMENT OF BOARD OF DIRECTORS

The Board of Directors shall be appointed by the Founder of LIFE CHANGING ANOINTING, INC.

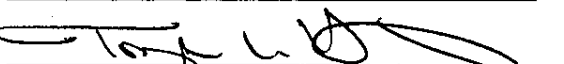

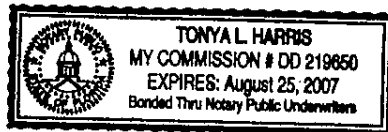
