# ARTICLES OF INCORPORATION OF CASTELLANO FAMILY FOUNDATION, INC.

I, the undersigned incorporator, hereby make, subscribe, acknowledge and file with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation not for profit in accordance with the laws of the State of Florida.

#### ARTICLE I

#### Name

The name of this corporation shall be:

Castellano Family Foundation, Inc.

#### ARTICLE II

#### Principal Office and Mailing Address

The address of the principal office and mailing address of this corporation shall be:

#### ARTICLE III

#### <u>Purposes</u>

- (a) This corporation is organized and shall be operated exclusively for charitable, educational, literary and scientific purposes, and other purposes for which an organization may be organized and operated under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended. In order to accomplish the foregoing, it shall be within the purposes of this corporation to establish and maintain charitable and educational activities, and to take such other action which, from time to time, shall be necessary or desirable to implement and further the said purposes.
- (b) It shall be within the purposes of this corporation to receive and maintain a fund or funds of real or personal property, or both, and subject to the restrictions and limitations hereinafter set forth, to use and apply the whole or any part of the income therefrom and the

principal thereof exclusively for the active conduct of its charitable or educational purposes directly or through one or more grantee organizations.

- (c) No part of the net earnings of this corporation shall insure to the benefit of any Director, officer of this corporation, member or any private individual (except that reasonable compensation may be paid for services rendered to or for this corporation affecting one or more of its purposes), and no Trustee, officer of this corporation, member or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of this corporation. No substantial part of the activities of this corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and this corporation shall not participate in, or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.
- (d) Notwithstanding any other provisions of these Articles of Incorporation, this corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or any statute of similar import (the "Code") or the regulations issued thereunder, or by an organization, contributions to which are deductible under Section 170(c)(2) of the Code and regulations issued thereunder.
- (e) Upon the dissolution of this corporation or the winding up of its affairs, the assets of this corporation shall be distributed exclusively to charitable, religious, scientific, literary, or educational organizations which then would qualify for the provisions of Section 501(c)(3) of the Code and the regulations issued thereunder, and no Trustee, officer or private individual shall be entitled to share in the distribution of any of the assets.

#### ARTICLE IV

#### **Powers**

- (a) This corporation shall have and exercise all powers necessary or convenient-to effect any and all of the charitable, educational, literary and scientific purposes for which this corporation is organized.
- (b) This corporation shall neither have nor exercise any power, nor shall it engage directly or indirectly in any activity, that would invalidate its status:
  - (i) As a corporation that is exempt from federal income taxation as an organization described in Section 501(c)(3) of the Code; or
  - (ii) As a corporation contributions to which are deductible under Section 170(c)(2) of the Code.

- (c) Notwithstanding any other provision of these Articles of Incorporation, all of this corporation's income for each of its taxable years shall be distributed at such time and in such manner as will not subject this corporation to tax under Section 4942 of the Code.
- (d) Notwithstanding any other provision of these Articles of Incorporation, this corporation shall not:
  - (i) Engage in any act of self-dealing (as defined in Section 4941(d) of the Code);
  - (ii) Retain any excess business holdings (as defined in Section 4943(c) of the Code);
  - (iii) Make any investments in such manner as to subject this corporation to tax under Section 4944 of the Code; or
  - (iv) Make any taxable expenditures (as defined in Section 4945(d) of the Code).

ARTICLE V

No Members

The corporation shall have no members.

#### Term of Existence

The term for which this corporation is to exist shall be perpetual.

#### ARTICLE VII

#### Registered Agent and Registered Office

#### ARTICLE IX

#### Officers and Directors

The affairs of this corporation shall be managed by a Board of Directors who shall be elected as provided in the by-laws, and by officers who shall be elected by the Board of Directors. The officers thus to be elected shall be a president, a secretary and a treasurer and such other officers as may be provided for in the by-laws of this corporation. The duties of the respective officers and the manner of filling vacancies in the offices of this corporation shall be as provided in the by-laws.

The number of Directors and the manner of filling vacancies in the Board of Directors shall be provided in the by-laws of this corporation. The number shall not be less than three, but may be any number in excess thereof. A quorum for the transaction of business shall be a majority of the Directors qualified and active, and the act of a majority of the Directors present at a meeting at which a quorum is present shall be the act of the Directors. Meetings of the Directors may be held within or without the State of Florida.

#### ARTICLE X

#### Directors
