The undersigned incorporator, desiring to form a corporation not-for-profit under the Chapter 6 of the laws of the State of Florida, hereby adopts the following Articles of Incorporation ("Articles"):

Article 1 NAME AND DEFINITIONS

The Association shall have perpetual existence.

Article 4 BOARD OF DIRECTORS

- 4.01 <u>Management by Directors</u>. The property, business and affairs of the Association shall be managed by a Board of Directors, which shall initially consist of three (3) persons.
- 4.02 <u>Election of Directors</u>. The Directors shall be elected in accordance with the procedures set forth in the Bylaws.
