#### ARTICLES OF INCORPORATION

The undersigned, a majority of who are citizens of the United States, desiring to form a Non-Profit Fault Based Community Service Corporation under the Non-Profit Law of the State of Florida, do hereby certify

#### ARTICLE I NAME

The name of the corporation shall be:

TEACHING MINISTRIES OF CHRIST FOUNDATION OF HOPE, INC.

#### **ARTICLE II**

The place in this state where the principal office of the Corporation is to be located is the City of New Smyrna Beach, Florida

### ARTICLE III

- A. The purpose for which this corporation is organized exclusively for religious, charitable, scientific, literary, and educational purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986 or corresponding provision of any future United States Internal Revenue law.
- B. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation in, or intervene in (including the publishing or distribution of statements any political campaign on behalf of any candidate for public office notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on:

- (a) by a corporation exempt under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code or
- (b) by a corporation, contributions to which are deductible under section 140 (c) (2) of the Internal Revenue Code, or corresponding section of any future Federal Tax code

# ARTICLE X

Upon the dissolution of the corporation, any assets remaining after payment of debts, of the corporation shall be disbursed to the Teaching Ministries Of Christ Fellowship International, Inc., within the meaning of section 501 (c) (3) of the Internal Revenue Code.

#### ARTICLE XI

This Corporation shall have the following powers:

- 1. Have succession by its corporate name for perpetuity.
- 2. Sue and be sued and appear and defend in all actions and proceedings in its corporate name to the same extent as a natural person.
- 3. Adopt and use a common corporate seal and alter the same, provided "Corporation Not for Profit: be contained therein.
- 4. Elect such officers and agents as its affairs shall require, and to allow them reasonable compensation.
- 5. To administer corporate affairs and exercise corporate powers.
- 6. Increase, or decrease by a vote of its members, as set forth in Article V thereof, the number of directors in no event less than three persons.
- Make contracts, incur liabilities, borrow money at such rates of interest as the directors may determine, issue its notes, bonds and other obligations, and secure any of its obligations by mortgage and pledge any or all of its property, franchises or income.
- Conduct its affairs, carry on its operations and have officer's and exercise the powers granted by this Article in any state, territory, district or possession of the United States or any foreign country.

- 9. Purchases, task, receive, lease, take by gift devise or bequest, or otherwise acquire, own, hold improve, use or otherwise deal in and with real or personal property, or any interest therein, wheresoever situate.
- 10. Acquire, enjoy, utilize, and dispose of patents, copyrights, and trademarks, and any licenses, and other rights or interests therein or there under.
- 11. Sell, convey, mortgage, pledge, lease, exchange transfer or otherwise dispose of all or any part of its property and assets.
- 12. Purchase take, receive, subscribe for otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge or otherwise dispose of and otherwise use and deal with shares and other interest or in obligations of other domestic or foreign corporation, whether for profit or not, associations, and partnerships or individuals, or direct or indirect of the United States, or of any other government, state, territory, governmental, district, municipality, or any instrumentality thereof.
- 13. Lend money for its corporate purposes, invest and reinvest its funds, and to take and hold real and personal property as security for the payment of funds so loaned or invested.
