ARTICLE I



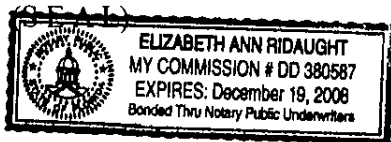
