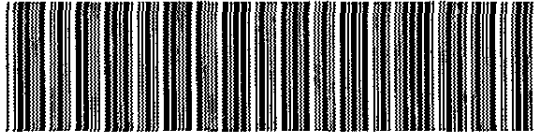

SECOND: The document number of the corporation (if known) is 1


THIRD: The effective date (or file date, if no effective date) of the Articles of Dissolution filed with the Florida Department of State is April 30, 2007
