



Articles of Amendment to Articles of Incorporation

Everybody's Able Amendment (EIN# 210.8971796)

- 1. Amendment to description of activities:**
 - a. A general description of the activity including its purpose and function.**
 - If given non-profit status, it is our intent to offer free therapeutic recreation activities in the Orlando area to individuals with mental and/or physical disabilities. Activities offered through Everybody's Able will be mainstreamed activities designed for individuals with mental or physical disabilities. The concept behind Everybody's Able is to provide accessible recreational based activities that will promote positive physical, mental, and emotional growth among individuals with disabilities. Activities will promote positive, age appropriate interactions with peers, family members, caregivers and the community at large. If given 501c3 status, Everybody's Able intends to solicit funds that will allow individuals with disabilities to participate in recreational activities such as (but not limited to) boating, kayaking, sailing, fishing, fitness programming, outdoor adapted physical activities, cooking, swimming, and therapeutic horseback riding.
 - b. When it was or will be initiated:**
 - Everybody's Able will begin soliciting funding sources (primarily through state, federal and private grants) as soon as we are given 501c3 status.
 - c. How, when, where and by whom it is or will be conducted.**
 - The program will be conducted at local public/private facilities in the Orlando area by qualified staff members hired by the President and Vice President of Everybody's Able.
 - d. Requirements a person or organization must meet in order to participate in or receive benefit from this activity.**
 - In order to receive services through the Everybody's Able program, participants must have a documented physical or mental disability and must have a medical release from their primary medical doctor to participate in the recreation program.
 - e. Any charges or fees, their amount and their basis.**
 - All programming will be free to participants and their families.
 - f. What the activity has or will accomplish.**
 - The Everybody's Able program plans to offer free programming to individuals with disabilities and their families in the Orlando area. Currently these individuals do not have access to qualified staff members or accessible community resources that will allow mainstreamed participation. The benefits of our proposed program include:
 - Physical Benefits:
 - Stretching of tight or spastic muscles
 - Decreased spasticity
 - Increased range of motion
 - Reduction of abnormal movement patterns

- Improved respiration and circulation
 - Improved appetite and digestion
 - Sensory integration.

Psychological Benefits:

- Improved self-confidence
- Increased interest in the outside world
- Increased interest in one's own life
- Development of patience
- Emotional control and self-discipline
- Sense of normalcy
- Increased focus and attention
- Decreased feelings of sadness/depression

Social Benefits:

- Improved social interaction with peers and friendships
- Increased experiences
- Enjoyment

Educational Benefits:

- Remedial Reading
- Remedial Math

ARTICLES OF INCORPORATION

- **Purpose:**
- The Corporation is organized and operated exclusively for charitable, educational, religious, or scientific purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code. The purpose for which this 501(c)(3) is organized is to

provide therapeutic rehabilitation, recreation, vocational and social opportunities for individuals with disabilities.

- **Inurement of Income:** No part of the net earnings of the corporation shall inure to the benefit of or be distributable to, its members, trustees, officers or other private persons except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered.
- **Operational Limitations:** Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions, to which are deductible under section 170(c)(2) of the Internal Revenue Law) or 9b) by a corporation, contributions, to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).
- **Dissolution Clause:** Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provisions for the payment of all liabilities of the corporation, dispose of all the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any such assets not disposed of shall be disposed of by the Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such, purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
