ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

ARTICLE III PURPOSE

The purpose for which the corporation is organized is exclusively for charitable and educational purposes. The Johnnie L. Phillips Foundation, Inc. is focused on the enactment of programs to support the youth in our community. Our goal is to prepare all youth to be upstanding citizens in our communities through empowerment in the areas of education, social competence and understanding, and economic development. Although all youth are welcome to participate, the Johnnie L. Phillips Foundation, Inc. is specifically on African American youth with a special emphasis on African American males. Statistics show that this group is disproportionately represented in the justice system and report lower levels of academic achievement than other groups. Therefore, the Johnnie L. Phillips Foundation, Inc. seeks to advance the educational opportunities available to this group and encourage our youth to strive for academic and overall excellence.

The Johnnie L. Phillips Foundation, Inc. will sponsor a scholarship program, which will be funded by charitable contributions from the public and fundraising activities conducted by the corporation.

No part of the net earnings of the Johnnie L. Phillips Foundation, Inc. shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above.

The Johnnie L. Phillips Foundation, Inc. shall not engage, other than as an insubstantial part of its activities, in activities that are not in furtherance of the purposes set forth above. Notwithstanding any other provision of these articles, the Johnnie L. Phillips Foundation, Inc. shall not carry on any other activities not permitted to be carried on by (a) a corporation that is exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or by (b) a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose.

ARTICLE IV MANNER OF ELECTION

Directors of the Johnnie L. Phillips Foundation, Inc. will be appointed by unanimous approval of Linda J. Phillips, LaShanta Phillips Taylor and Tangela N. Phillips; widow and daughters of the late Johnnie L. Phillips. Directors will serve on a voluntary basis.
