ARTICLE OF INCORPORATION OF

HOUSING OPPORTUNITIES and PERSONAL EMPOWERMEN

A Florida Non-Profit Corporation

ARTICLE I

The name of this corporation is HOUSING OPPORTUNITIES and PERSONAL EMPOWERMENT, INC

ARTICLE II

The primary place of business and mailing address for HOUSING OPPORTUNITIES and PERSONAL EMPOWERMENT, INC is 2729 West Pensacola Street, Tallahassee, FL 32304.

ARTICLE III

The specific and primary purposes for which this corporation is formed are to operate for the advancement of charity and for other charitable purposes, by the use of its funds for such purposes, and particularly to deliver services to homeless persons; to provide or cause to be provided, temporary or transitional shelter for families, especially those with children; to undertake, promote, develop and encourage employment counseling, training and placement of homeless persons; and to undertake activities to foster the prevention of homelessness.

The general purposes for which this corporation is formed are to operate exclusively for such charitable purposes as will qualify it as an exempt organization under Section 501(c) (3) of the Internal Revenue Code of 1954 or corresponding provisions of any subsequent federal tax laws. This corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office.

ARTICLE IV

Members of the Board of Directors may be elected at any regularly scheduled board meeting provided a quorum is present. New board members become active board members immediately upon election. The Term of Office shall also begin upon election. Each director shall hold office until his/her death, resignation, term expiration or removal. When the number of vacancies on the board does not exceed the number of candidates, a simple majority of votes in favor of election is required. Should the number of candidates exceed the number of vacancies, those with the greatest number of votes shall be the Directors.

ARTICLE V

ARTICLE VIII

Subject to the limitations contained in bylaws, and any limitations set forth in the Corporations Not for Profit law of Florida, concerning corporate action that must be authorized or approved by the members of the corporation, bylaws of this corporation may be made, altered, rescinded, added to, or new bylaws may be adopted either by a resolution of the Board of Directors or by following the procedures set forth therefore in the bylaws.

ARTICLE IX

The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof, or to the benefit of any private individual.

ARTICLE X

Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment of all debts and liabilities of the

corporation, shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501 (c) (3) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws.

ARTICLE XI

Amendments to these Articles of Incorporation may be proposed by a resolution adopted by the board of directors for their vote. Amendments may be adopted by a vote of two- thirds of a quorum of members of the corporation.
