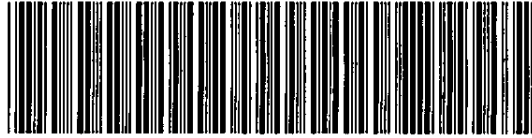

**Articles of Incorporation**  
of




