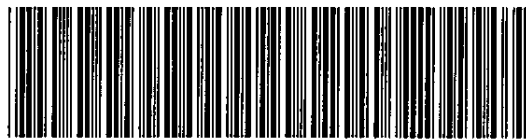

ARTICLE I. NAME

Our organization shall be known as and referred to as the "Bay Breeze Winterguards Inc."

ARTICLE II: PRINCIPAL OFFICE

The current operational and mailing address will be 711 GABRIEL STREET, PANAMA CITY, FLORIDA 32405.

ARTICLE 111: PURPOSE

This club is organized for non-profit activities solely for the support of Winterguard program in Bay County, Florida for the purposes of making of distributions to organizations under section 501(c)(3) of the internal Revenue code (or corresponding section of any future Federal tax code). Winterguard is a competitive performing arts program for young adults. Please see www.baybreezewinterguards.org for more info.

No part of the net earnings of this organization shall inure to the benefit of , or be distributed to its members, trustees, directors, officers or other private persons except for reasonable compensation for services rendered for carrying our the purpose of this organization (promote the Winterguard programs of Bay County, Florida). No part of the net earnings of this organization shall be used of any political purposes either in support or attempting to influence legislation or political Campaign. The "Club" shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal Income tax under section 501(c)(2) of the Internal Revenue Code or any future Federal Tax Code.

Upon dissolution of this organization's assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c) (3). Bay High School Band Booster Club shall take possession of all assets upon dissolution of this organization.

The objectives of the club are as follows:

To assist the Bay County Winterguard programs financially and through leadership in achieving a means to provide opportunity for competition in the Indoor Winter Guard season corresponding but not limited to the GulfCoast Colorguard & Percussion Circuit's and WinterGuard International's rules and guidelines.

ARTICLE IV: MEMBERSHIP and ELECTIONS

Section 1. Any person with direct or with bona-fide interest in the Color guard or Winter Guard program is eligible for membership.

Section 2. Voting privileges will be limited to officers and parents of performing members.

SECTION 3. ANNUAL MEETING. The annual meeting of membership of the Club shall be held on the second Saturday of October each year. Officers shall be nominated and elected at the Meeting each year. The executive board shall take office immediately following elections.
