ARTICLE I NAME

The name of the corporation shall be :

- Living Word of God in Christ Ministries, Inc

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be :

- During the start-up phase, Living Word of God in Christ Ministries services and meetings will be held at 1301 34th Street South, a ministry facility in south St. Petersburg that is utilized by an array of nonprofit agencies.
- Living Word of God in Christ Ministries is currently negotiating a contract with The Owner of 1301 34th Street South Mr, John Tatum.
- Living Word of God in Christ Ministries goal is having 1301 34th Street South for a permanent home.

ARTICLE III PURPOSE

The purpose for which the corporation is organized is :

- To reach lost souls with the word of God.
- To help people who are dealing with drug and alcohol dependency.
- Living Word of God in Christ Ministries will provide AA and NA and CA meetings with literature to help with information that they need to raise their self-esteem.
- In addition, Living Word of God in Christ Ministries will provide clothes, food and personal supplies to those who are in need .

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

- During the start up phase , each director shall hold office for a period of one year and until his/ her successor is elected and qualifies. In the second year, the board term for directors will increase to a period of three years.
- Board meetings will be held bimonthly (six times) during the first year, and increase to a monthly basis during the second year and beyond.
- One meeting- the last annual gathering of directors-per year will be designated for the election of new board members. Voting shall consist of written ballots. Each director may cast one vote per candidate. The candidate with the largest number of votes will be elected to serve on the board.
