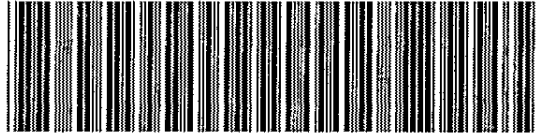

## **ARTICLES OF INCORPORATION**

**OF**

### **PINES CHARTER HIGH SOCCER BOOSTER CLUB, INC. A FLORIDA NOT-FOR-PROFIT CORPORATION**

We, THE UNDERSIGNED, acting as Incorporator of a not for profit Corporation pursuant under the Florida Not for Profit Corporation Act, as set forth in Chapter 617, Florida Statutes, as amended, adopts the following Articles of Incorporation of such corporation.

#### **ARTICLE 1-NAME**

The name of the corporation shall be:

**PINES CHARTER HIGH SOCCER BOOSTER CLUB, INC.**

Hereinafter referred to as the "Corporation."

#### **ARTICLE 11-PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS**

Pembroke Pines Charter Senior High School  
C/o Mrs. Cynthia Reyes

Pembroke Pines, Florida 33331

#### **ARTICLE 111- PERIOD OF DURATION**

The period of duration of this corporation shall be perpetual unless sooner dissolved according to law.

#### **ARTICLE IV- PURPOSES**

The Corporation is organized and operated exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not to be carried on (i) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, ( or the corresponding provisions of any future United States Internal Revenue Law ), or (ii) by a corporation, contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code of 1986 ( or the corresponding provision of any future United States Internal Revenue Law).

## **ARTICLE V- RESTRICTIONS ON ACTIVITIES**

No substantial part of the activities of this corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, nor shall this corporation participate in or intervene in ( including publishing or distributing of statements) any political campaign on behalf of (or in opposition to) any candidate for public office.

## **ARTICLE V1- MEMBERSHIP**

The corporation shall consist of members whose qualifications and appointment shall be as provided for in the by laws.

## **ARTICLE V11- REGISTERED OFFICE AND AGENT**

The Corporation's registered office shall be located at 17189 Sheridan Street, Pembroke Pines, Florida 33331, and Pembroke Pines Charter Senior High School, c/o Mrs. Cynthia Reyes, is the registered agent of the corporation.

## **ARTICLE V111- BOARD OF DIRECTORS**

The Board of Directors of the Corporation shall consist of three (3) persons. The number of directors may be increased or decreased from time to time by an amendment to the by laws; however, there shall never be less than three directors. All directors shall be selected as provided for in the bylaws.

## **ARTICLE 1X- OFFICERS**

The officers of the Corporation shall be a President, Secretary, Treasurer and such other officers as may be provided by the bylaws. Initial officers shall be:

## **ARTICLE X- AMENDMENTS**

These Articles of Incorporation may be amended at any regular or special meeting of the Board of Directors by a majority vote of those present; provided that notice of the intention to submit amendments shall have been given as provided by the bylaws.

**ARTICLE X1- DISTRIBUTION OF ASSETS UPON DISSOLUTION**

The property of this corporation is irrevocably dedicated to charitable and educational purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any private person. Upon dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable and educational purposes and which has established its tax exempt status under Section 501 (c)(3) of the Internal Revenue Code.
