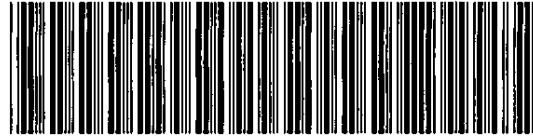

ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

Article I Name

The name of the corporation shall be: Mount Zion Missionary Baptist Church of Laurel, Incorporated

Article II Principal Office

The principal place of business and mailing address of this corporation shall be: 703 Wallace Street, Laurel, Florida 34272. Mailing address is 7515 43rd Court East, Sarasota, Florida 34243.

Article III Purpose

(a) The purpose for which the corporation is organized is: organized exclusively for charitable, religious, educational, and scientific purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

(b) This corporation shall also have the right to purchase or otherwise acquire, and to own mortgage, pledge, sell, assign and transfer or otherwise dispose of real and personal property and service of every class, kind and description; and to lawfully do any and all things necessary, suitable and proper for the accomplishment of these purposes. No part of any net earnings shall in use to the benefit of any member, director, or officer.

(c) This corporation shall have and exercise all rights and powers conferred upon corporations under the laws of the state of Florida, provided, however, that this corporation is not empowered to engage in any activity that in itself is not in furtherance of its purpose as set forth in subparagraphs (a) and (b) (c) of this article.

ARTICLE IV MANNER OF ELECTION

The manner in which the director are elected or appointed:

- (a) Director shall be elected or appointed in a manner and for the terms provided in the articles of incorporation or the bylaws shall be held at any special meeting or annual meeting.
- (b) A board of directors must consist of three or more individuals, with the number specified in or fixed in accordance with the articles of incorporation or bylaws.
- (c) The number of directors may be increased or decreased from time to time by amendment to, or in the manner provided in, the articles of incorporation or the by laws, but the corporation must never have fewer than three directors.
- (d) A board of directors numbering not less than three (3) not more than eleven (11) members to be elected at any special or annual meeting shall manage the affairs of this corporation.
- (e) The number of directors herein provided for may be changed by a bylaw duly adopted by the members entitled to vote. The directors shall take action only upon direction of the Church body in business session.

- (f) Officers of this corporation shall be a Moderator, Church Clerk, and a Senior Board member, and three board members.
- (g) Any officer may resign at any time by delivering notice to the corporation. A resignation is effective when the notice is delivered unless the notice specifies a later effective date. If a resignation is made effective at a later date and the corporation accepts the future effective date if the board of directors provides that the successor does not take office until the effective date of the pending vacancy.
- (h) A board of directors may remove any officer at any time with or without cause. Any officer or assistant officer, if appointed by another officer, may likewise be removed by such officer.


