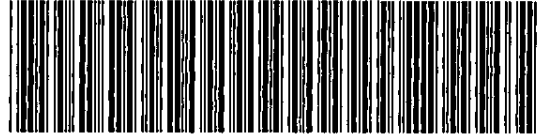

ARTICLES OF INCORPORATION

Article I

The name of this corporation shall be Seminole #4147 Fraternal Order of Eagles Ladies Auxiliary, Inc.

Article II

The principal place of business and mailing address of this corporation shall be:
6987 54th Ave N, St. Petersburg, FL 33709

Article III

This corporation is formed for the purpose of aiding the Fraternal Order of Eagles in carrying out its charitable, humanitarian, patriotic, and other purposes, to which the Fraternal Order of Eagles is dedicated. All of the activities must be designed to promote the objectives of the Fraternal Order of Eagles. The Auxiliary shall have no purposes that are apart from the aims of the Fraternal Order of Eagles. Said Auxiliary is incorporated in conformity with, subject to and under the jurisdiction and control of the Laws of the Fraternal Order of Eagles.
