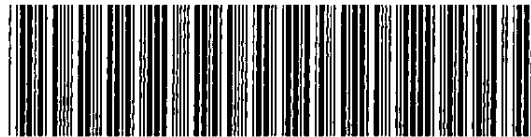

of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization
or organizations , as said court shall determine, which are organized and operated exclusively for such purposes.
