ARTICLES OF INCORPORATION
of

Riverview Christian Fellowship, Inc.

We, the undersigned, for and in behalf of the members of this organization, who duly organized this body as a church on the 16 day of May, 2007, do hereby adopt the following articles of Incorporation, for the purpose of forming an ecclesiastical corporate, under and pursuant to the provisions of to chapter 617, Florida Statutes (F.S.).

Effective Date May 20, 2007

Article 1. Name

The name of this corporation shall be Riverview Christian Fellowship, Inc. The Principal address shall be:

Riverview, Fl. 33569

Article 2. Purpose

The general purposes for which this corporation is formed shall be:

A. To preach the Gospel, to administer the ordinances of the New Testament, to minister to the spiritual needs of its members and all people everywhere, to train Christian workers for the Lord's work, and to further the evangelization of the world by winning men, women, and children to a living faith in Jesus Christ.

B. To take, secure, accept, hold or acquire, by gift, purchase, legacy or otherwise, real and personal property, whenever it may deem the same proper, necessary and expedient, in the work and purposes for which this body was organized and incorporated; and to hold, lease, encumber, give, exchange or sell and transfer and dispose of the same, in part or in whole, when it deems such action expedient, necessary or incidental thereto; all such acts to conform to the laws of this state.

Article 3. Assets

A. No part of the net earnings of the church shall used to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payment and distributions in furtherance of the purposes set forth in Article 2. A.

B. On the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets of this corporation shall be distributed to an organization (or organizations) organized and operated exclusively for religious purposes and that is tax exempt under Section 501(c)(3) of the Internal Revenue Code of 1986.

Article 4. Period of Corporate Existence

The period of situation of corporate existence of this corporation shall be perpetual.


Article 5. Other provisions

A. This corporation is organized exclusively for religious purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code of 1986 (or the corresponding section of any future United States Internal Revenue Law). Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation, and the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law, or (b) by a corporation , contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

B. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, except as provided in Section 501(h) of the Internal Revenue Code of 1986, and this corporation shall not participate in or intervene in (including publishing or distributing statements) any political campaign on behalf of any candidate for public office except as otherwise provided in Section 501(h) of the Internal Revenue Code of 1986.

C. Method of election of director, trustees, and officers is as stated in the bylaws.
