### AMENDED AND RESTATED ARTICLES OF INCORPORATION OF READING DISABILITIES AND DYSLEXIA AWARENESS GROUP, CORP.

These Amended and Restated Articles of Incorporation of Reading Disabilities and Dyslexia Awareness Group, Corp., a Florida not for profit corporation (the "Corporation"), dated as of March 18, 2008, are being duly executed and filed by Aimee Spivey, its chief executive officer, to amend and restate the Corporation's original articles of incorporation, which were filed on May 16, 2007. The original name of the Corporation was "Reading Disability and Dyslexia Awareness Foundation Corp." which was changed by an amendment filed on January 22, 2008 to the Corporation's current name. These Amended and Restated Articles of Incorporation were duly executed and are being filed in accordance with Section 617.1007 of the Florida Not For Profit Corporation Act.

#### ARTICLE I Name, Street Address and Mailing Address

The name of the corporation is: Reading Disabilities and Dyslexia Awareness Group, Corp.

The street address and mailing address of the principal office of the corporation  $[5]{60}$ Kestrel Point Avenue, Lithia, FL 33547.

#### ARTICLE II Term of Existence

The corporation shall have perpetual existence.

### ARTICLE III <u>Purpose</u>

The Corporation is organized and shall be operated exclusively for educational and charitable purposes, including, for such purposes providing grants to other organizations to facilitate the awareness and treatment of reading disabilities and dyslexia.

The Corporation shall have all powers now or hereafter granted by law, and in addition thereto shall have all powers lawfully necessary or required to carry out its purposes and objects. All of the assets or earnings shall be used exclusively for the purposes hereinabove set out, including payment of expenses incidental thereto. No part of the net earnings shall inure to the benefit of any individual, and no part of its activities shall be for the carrying on of propaganda or otherwise attempting to influence legislation. 03/27/2008 11:07 FAX

## ARTICLE IV <u>Members</u>

The qualifications of members and the manner of admission of members shall be as specified in the bylaws of the Corporation.

#### ARTICLE V Registered Office and Agent

The street address of the registered office of the corporation is 6020 Kestrel Point Avenue, Lithia, FL 33547, and the name of its registered agent at such address is Aimee Telese Spivey.

### ARTICLE VI Directors

The corporation shall have three (3) directors. The number of directors may be increased or decreased from time to time and their election and appointment shall be as specified in the bylaws of the corporation, provided that the corporation shall always have at least three directors.
