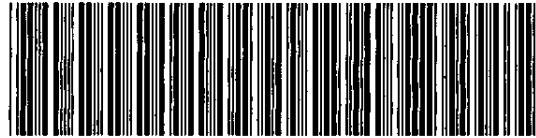



The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is First United Pentecostal Church of Freeport, FL, Inc.

ARTICLE II - DURATION

The corporation shall exist perpetually.

ARTICLE III - PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office of the corporation shall be 391 S. Jackson Street, Freeport, Florida 32439, and the mailing address of the corporation shall be P.O. Box 695, Freeport, Florida 32439.

ARTICLE IV - PURPOSES OF THE CORPORATION

The purpose of the corporation shall be to establish and maintain a place of worship; to unite a people of like faith in the bonds of brotherly love and fellowship; to meet together to truly worship God in spirit and in truth, and to receive spiritual teaching; to point the lost to the way of life by publishing at home and abroad the true plan of salvation, exhorting believers to be filled with the Holy Spirit; and to provide rules of Christian conduct, based upon the Word of God.
