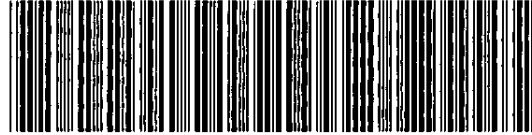

ARTICE III. Said corporation is formed exclusively charitable and educational  
 under section 501(c)3 of the Internal Revenue Code. Community and Economic

### Article 3 Cont'd

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the corporations shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provisions of these articles, the corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from federal income tax under section 501c3 of the internal revenue code (or corresponding section of any future federal tax code) or (b) by a corporation, contributions to which are deductible under section 170c(2) of the internal revenue code (or corresponding section of any future federal tax code).

In the event of dissolution, all of the remaining assets and property of the organization shall after payment of necessary expensed thereof be distributed for one or more exempt purposes within the meaning of section 501c3 of the internal revenue code of 1986, i.e. religious, charitable, educational, scientific, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. However, if the named recipient is not then in existence or no longer a qualified distributee, or is unwilling or unable to accept the distribution, then the assets of this corporation shall be distributed to a fund, foundation or corporation organized and operated exclusively for the purposes specified in section 501c3 of the internal revenue code (or corresponding section of any future federal tax code). Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county that the principal office of the organization is then located, exclusively for such purposes.
