

ARTICLES OF CORRECTION TO ARTICLES OF INCORPORATION FOR LAKESIDE CHRISTIAN SCHOOL, INC.

Pursuant to the provisions of Section 617.0124, Florida Statutes, Lakeside Christian School, Inc. files these Articles of Correction within 30 days of the file date of the document being corrected.

FIRST: These Articles of Correction correct the Articles of Incorporation filed with the Florida Department of State on May 23, 2007 under document number N07000005176.

SECOND: Article V of the Articles of Incorporation contains an incorrect statement and is hereby corrected to read as follows:

"ARTICLE V DISTRIBUTION OF ASSETS ON DISSOLUTION

In the event the Corporation dissolves, the Board of Directors shall, after paying or making provisions for the payment of all of the liabilities of this Corporation, distribute all remaining assets of this Corporation exclusively to Lakeside Community Chapel of Clearwater, Inc. so long as it is a "qualified organization," otherwise to other charitable organizations, which are "qualified organizations," as described herein, or should be distributed to the federal, state, or local governments for one or more public purposes. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the Corporation is then located, exclusively for one or more exempt or public purposes. A "qualified organization" is an organization described in Code Sections 501(c)(3), 509(a)(1) or 509(a)(2)."

THIRD: All other provisions of the Articles of Incorporation remain the same as originally filed.
