## **Articles I:**

# Article III:

The specific purpose for which this corporation is organized: The purpose for which this corporation is formed are to: inspire and mobilize youth and young adults (boys & girls between ages 5 & 16) of all nations through the integration of sports, special events, and clinics, all within the meaning of 501(c) (3) of the Internal Revenue Code.

"Notwithstanding any other provision of these articles, this corporation shall not, except to an institutional degree, engage in any activities or exercise any powers that are not in furtherance of the purpose of this corporation."

No part of the net earnings of the Corporation shall inure to the benefit of any member, trustee, officer of the corporation, or any private individual, except that reasonable compensation may be paid for services rendered to or for the Corporation affecting one or more of its purposes, and no member, trustee, officer of the Corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation. No substantial part of the activities of the Corporation shall not participate in or intervene in, including the publication or distribution of statements, any political campaign on behalf of any candidate for

public office.

Upon the dissolution of the Corporation or the winding up of its affairs, the assets of the Corporation shall be distributed exclusively to one or more charitable, organizations which would then qualify under the provisions of Section 501(c) (3) of the Internal Revenue Code and its Regulations as they now exist or as they may be hereafter amended, or to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.

### **Article IV**

The first members of the Corporation shall be all persons subscribing to the Articles of Incorporation. Membership in the Corporation shall be open and granted to all persons and organization sharing the same interest. The officers of the corporation shall be President, Vice President, Secretary, and a Treasurer. The corporation may also have Chairperson of the Board, one or more Vice Presidents, Assistant Treasurers, and other such officers with such titles as may be determined from time to time by the Board of Directors. The directors and manner of their election shall be regulated in the bylaws.

#### Article V

The corporation may (but need not) have voting members, and such membership, if any, and classes thereof, shall be as defined in the corporation's by-laws. The management and affairs of the corporations shall be at all times under the direction of a Board of Directors, whose operations in governing the corporations shall be defined by statue and by the corporation's by-laws. No member or Director shall have any right, title, or interest in or to any property of the corporation.
