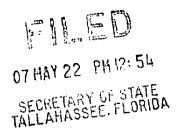

#### ARTICLES OF INCORPORATION OF AMERICA'S FUTURE LEADERS, INC.

The undersigned natural person of the age of eighteen years or more, acting as incorporator for a non-for-profit corporation in compliance with Chapters 607 and 617 of the Florida Business Corporation Act (the "Act"), adopts the following Articles of Incorporation:

#### ARTICLE I

The name of the corporation is: America's Future Leaders, Inc. (the "Corporation").

## ARTICLE II Principal Office

The principal place of business and mailing address of the Corporation is 1452 El Pardo Drive, Trinity, Florida 34655.

#### ARTICLE III Purpose

The purpose for which the Corporation is organized is to operate exclusively for educational and charitable purposes, within the meaning of Sections 501(c)(3) and 170(b)(1)(A)(ii) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United State Internal Revenue law), and, consistent therewith, to provide scholarship-enabling services to students via a modern online medium. The Corporation is irrevocably dedicated to, and operated exclusively for, nonprofit purposes; and no part of the income or assets of the Corporation shall be distributed to, nor inure to the benefit of, any individual.

The Corporation is empowered on a nonprofit basis:

- (a) To buy, own, sell, assign, mortgage or lease any interest in real estate and personal property and to construct, maintain and operate improvements thereon necessary or incident to the accomplishment of the purposes set forth in this Article III.
- (b) To borrow money and issue evidence of indebtedness in furtherance of any or all of the objects of its business, and to secure the same by mortgage, pledge or other lien on the Corporation's property.
- (c) To do and perform all acts reasonably necessary to accomplish the purposes of the Corporation.
- (d) To work in close cooperation with other agencies and foundations that may assist the Corporation in accomplishing its purposes and promote positive opportunities for the community served by the Corporation.
- (c) In the event of the dissolution of the Corporation or the winding up of its affairs, or other liquidation of its assets, the Corporation's property shall not be conveyed to any organization

created or operated for profit or to any individual for less than the fair market value of such property, and all assets remaining after the payment of the Corporation's debts shall be conveyed or distributed only to any organization or organizations created and operated for charitable purposes and then recognized as exempt by the Internal Revenue Service as exempt from federal income tax under Section 501(c)(3) (or its successor) of the Internal Revenue Code.

### ARTICLE IV Manner of Election

The manner in which directors are elected or appointed shall be stated in the Bylaws of the Corporation.
