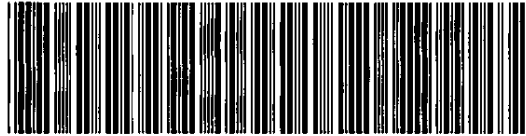

## **Amendment to Official Incorporation documents:**

**Section 1 - Number, Election, and Term of Office.** The number of the Trustees of the Corporation shall be 3. This number may be increased or decreased by the amendment of these bylaws by the Board but shall in no case be less than 3 director(s). The Board of Trustee shall be ~~elected each year~~ replaced or ask to step down from their official capacity as a trustee, when their behavior or actions poses any threat to the corporation and shall abide by the rules stated in the by-laws. If this corporation has no members then the Board shall be elected by a majority of the votes of the then current Board. If the corporation has members then the Board shall be elected by the members at their annual meeting. Each director shall hold office until the next annual meeting, and until his successor is elected and qualified, or until his prior death, resignation, or removal. Each elected officials would serve a terms deemed necessary by the Board, ~~but not more than 2 consecutive years.~~ The officers will hold general meeting, when they deemed it's necessary.

Dharamdath Hanoman, is recognized as the designated priest for the duration of the temple life. His official capacity as a priest does not limit him to only perform religious function, but gives him the authority to resolve, coach and guide all in the path of self realization and enlightenment. The priest shall not receive a salary, as he serves in this capacity. The priest will follow all guideline in accordance with the by-laws.

The corporation shall have three Trustees, President, Vice-President, Treasurer, Secretary and Committee Members selected by the governing body to take care of daily functions of the temple

**Section 2 - Resignation and Removal.** Any officer may resign at any time by giving written notice of such resignation to the President or the Secretary of the Corporation. Unless otherwise specified in such written notice, such resignation shall take effect upon receipt thereof by the Board member or by such officer, and the acceptance of such resignation shall not be necessary to make it effective. Any officer may be removed, either with or without cause, and a successor elected by a majority vote of the Board at any time. But all due care and consideration will take into consideration before removal of officers. Unless, the officer have behaved inappropriately, that it would create and cause problems for the organization. Any officers of the organization, with willful intentions uses his offices to cause harm or discomfort to any minor, senior citizen and public at large will be asked to resign from their capacity and will not be given an opportunity to hold a position in this organization. Officer will be asked to resign if they failed to perform their duties.
