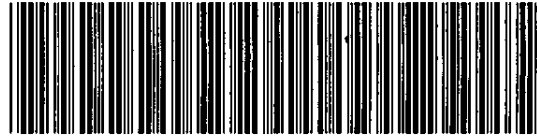

**ARTICLES OF INCORPORATION OF
ABLAZE Evangelism Ministry, Incorporated**

Article of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the State of Florida, do hereby certify:

**ARTICLE I
NAME / REGISTERED OFFICE**

The name of this corporation shall be: ABLAZE Evangelism Ministry, Incorporated. The corporation's registered office shall be at: 2201 State Road 16, St Johns County, St. Augustine, FL 32084. The mailing address of the corporation shall be: PO Box 920 St. Augustine, FL 32085.

**ARTICLE II
PURPOSE**

The corporation shall be organized exclusively for charitable, religious, and educational purposes furthermore the carrying out of the commands and doctrines of the Bible. Within the means of section 501(c)(3) of the Internal Revenue Code of 1986 as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations the also qualify as Section 501(c)(3) exempt organizations. To this end the organization shall evangelize, children and adults and train others to fulfill the purposes thereof. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise shall be devoted to said purposes.

**ARTICLE III
LIMITATIONS**

At all times the following shall operate as conditions restricting the operations and activities of the corporation:

1. No part of the net earnings of the corporation shall inure to any member of the corporation not qualifying as exempt under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, nor to any director, or officer of the corporation, nor to any private persons, except solely such reasonable compensation that the corporation shall pay for services actually rendered to the corporation, or allowed by the corporation as a reasonable allowance for authorized expenditures incurred on behalf of the corporation.
2. No substantial part of the activities of the corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.
3. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended.

4. The corporation shall not lend any of its assets to any officer or director of this corporation or guarantee to person the payment of a loan by an officer or director of this corporation.

ARTICLE IV DIRECTORS / MEMBERS

The corporation shall have no voting members. The management and affairs of the corporation shall be at all times under the direction of the Board of Trustees, whose operations in governing the corporation shall be defined by statute and by the corporations by-laws. No director or officer shall have any right, title, or interest in or to any property of the corporation.

The initial Board of Trustees shall serve until January 13, 2008 and will be eligible for re-election as per the by-laws, at that meeting.

ARTICLE V DEBT OBLIGATIONS AND PERSONAL LIABILITY

No officer or Director of this corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any property of the officers or Director be subject to the payment of the debts or obligations of this corporation.

ARTICLE VI DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed to one or more organizations with exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
