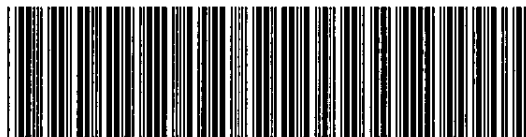

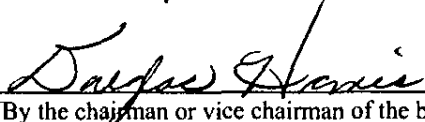

ARTICLE III PURPOSE:
