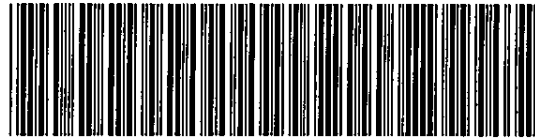

### **Article I      Name**

### **Article three III      Purpose clause**

The corporation is organized exclusively for charitable purposes and will provide assistants to newly legal non- English speaking immigrants to the united state in the following area:

- 1- Help legal immigrants to find work and their children to find schools.
- 2- Search for suitable, modest and safe residents for both married and singles.
- 3- Help families to over-come language barriers and improve their English communications
- 4- Familiarized the new comers to the united state's real democracy and life style.

**Article X                      Other registrations.**




