The undersigned, as incorporator, desiring to organize a corporation not for profit under Chapter 617 of the Florida Statutes, sets forth the following:

ARTICLE I

The name of the corporation shall be Greater Faith Christian Ministries, Inc.

ARTICLE II

The principal place of business and mailing address of this corporation shall be:

ARTICLE III

The purpose for which the corporation is organized is:

- Nonpolitical
- To be devoted to religious and spiritual purposes, especially the preaching and teaching of the gospel of our Lord Jesus Christ.
- The healing and building of the community in which it labors and serves by every means consistent with the gospel.
- To promote a spirit of fellowship and a closer relationship between the body of believers (members) of this organized corporate ministry.

The corporation may also have for its purposes any lawful venture not for profit and for the advancement of God's kingdom and the gospel of Jesus Christ.

ARTICLE IV

The Articles of Incorporation of this corporation shall be amended as the need arises by a majority ruling of the board of directors at any official meeting for such action to take place.


