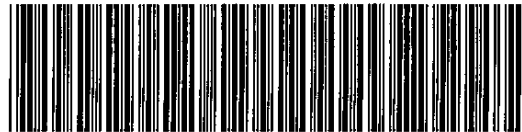



The undersigned incorporator hereby forms a corporation under Chapter 617, Florida Statutes

1. The corporate name shall be: JERRY DOLINER'S KIDS, INC.
2. The street and mailing address of the corporation shall be:
