

Article I - Name

Article II - Principal Office

Article III - Purpose

The Purpose of Saint Paul's Community Development Corporation is to improve the quality of life of the community's needy, empowering individuals, strengthening families and building neighborhoods by providing affordable housing, educational opportunities, and counseling.

Article IV - Manner of Election

The affairs of the Corporation shall be managed by a board of directors consisting of not less than three (3), and not more than fifteen (15). Directors will be elected by members of the Corporation, and will serve for a two year term.

Article VIII - Non-Profit/Fiscal Management

This corporation is organized for any lawful purpose for which corporations may be incorporated in this jurisdiction under the Florida Non-Profit Corporation Act. No part of the net earnings of the corporation shall be used to the benefit of, or be distributable to its members, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III herein.

Article IX - Bylaws

The bylaws of the corporation are made, altered or rescinded by consent of a majority of the membership. In order to change the corporation bylaws the Board of Directors shall arrange for a meeting of the membership specifying the purpose of the meeting. The Board of Directors shall advise the membership of the subject of the meeting to include location and time at least ten (10) days prior to the meeting.

Article X - Amendments

These articles of Incorporation may be amended by the act of the Board of Directors of the Corporation. Such amendments to these articles shall require a concurring vote of majority of the Corporation members present.

Article XI - Dissolution

Upon dissolution of the corporation, the board of directors shall; after paying or making provisions for the payment of all liabilities of the corporation, dispose of all assets of the corporation, in accordance with state law, and such manner as the board of directors shall determine.
